

# Plotting on Google Static Maps in R (RgoogleMaps, Version 1.2.0.6)

## 1 The RgoogleMaps package

The Google Static Maps API lets you embed a Google Maps image on your webpage without requiring JavaScript or any dynamic page loading. The Google Static Map service creates your map based on URL parameters sent through a standard HTTP request and returns the map as an image you can display on your web page.

Note: The Google Static Maps API does NOT require a Maps API key any longer.

This package serves two purposes:

- Provide a comfortable R interface to query the Google server for static maps
- Use the map as a background image to overlay plots within R. This requires proper coordinate scaling.

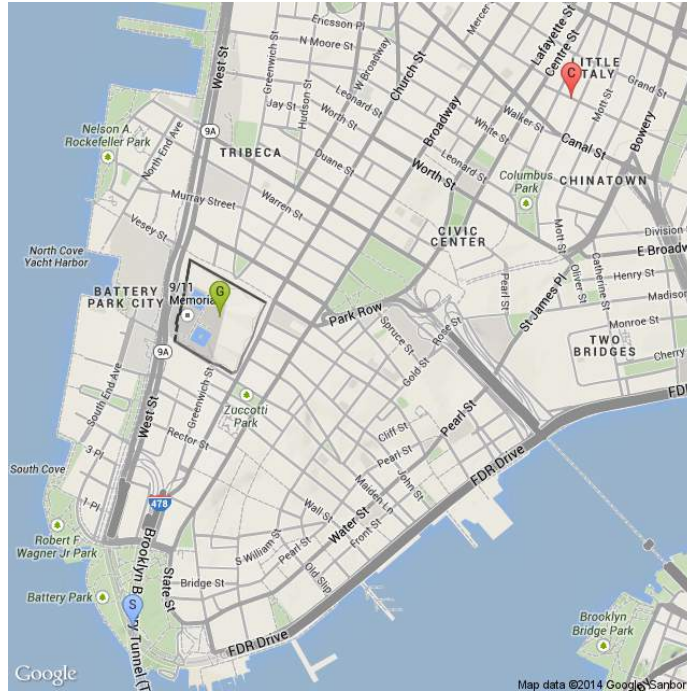


Figure 1: Static map of terrain type with markers.

The first step naturally will be to download a static map from the Google server. A simple example is shown in Fig. 1:

Of course, one can do without the markers and/or just pass a bounding box, see Fig. 2:

The function `qbbox()` basically computes a bounding box for the given lat,lon points with a few additional options such as quantile boxes, additional buffers, etc. In order to plot the map we need the package `rgdal`. We further need a way to change the current user coordinates, as set by `par('usr')` to our liking. The library `TeachingDemos` contains a function `updateusr()` that does exactly that. We took the liberty of including it in our package.

The function `LatLon2XY(lat,lon,zoom)` computes the coordinate transformation from lat/lon to map tile coordinates. It returns the tile coordinates as well as the pixel coordinates within the Tile itself. We compare this projection with more standard projections used in the GIS community in the appendix.

The choice of a proper zoom value is made easy via the function `MaxZoom()` which finds the maximum zoom level that fits the provided lat/lon ranges obeying the max size limitation of  $640 \times 640$  pixels.

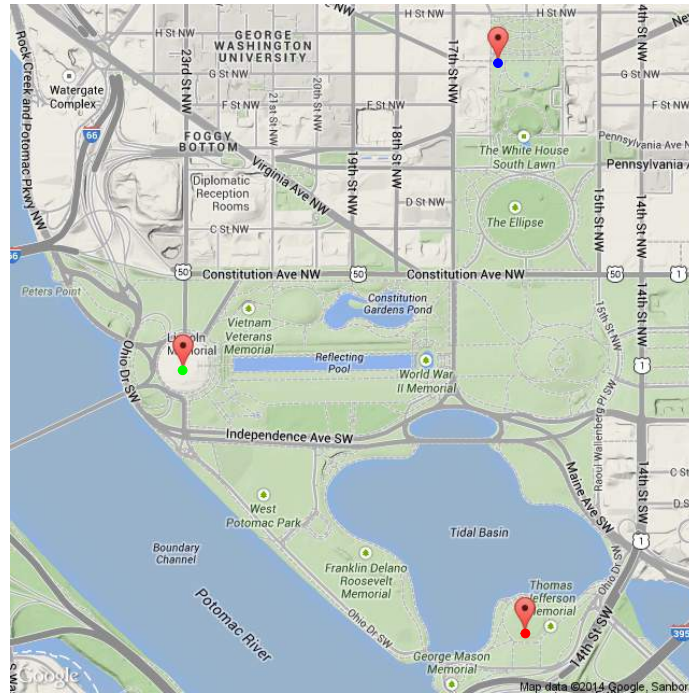


Figure 3: Testing point overlay.

The main function that overlays points (can easily be extended to lines or any other object) is *PlotOnStaticMap()*. The following simple sequence of calls serves to test the coincidence of the markers placed by Google and the corresponding points overlaid by *PlotOnStaticMap()*, see Fig. 3. Note that we select terrain style to make the colored points more discernible.

And lastly, one more fun example. The Coso geothermal field (e.g. [http://geology.about.com/od/mineral\\_resources/ig/cosogeotherm/](http://geology.about.com/od/mineral_resources/ig/cosogeotherm/)) is America's second-largest producer of geothermal electricity, with a continuous output of 270 megawatts. It relies on superheated groundwater that boils into steam at less than 2 kilometers depth, thus it is classified as a hot-water field. (The Geysers, world's largest geopower site in northern California, produces pure steam.)

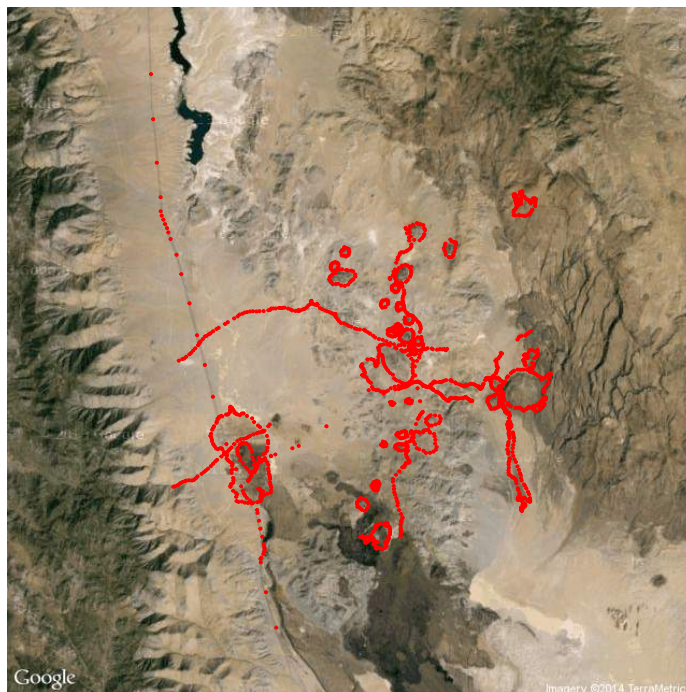


Figure 4: Coso Geothermal Region Faults.

Geothermal power has been produced at Coso since 1987 by a private contractor for the U.S. Navy, which acquired the land in 1943 as part of the China Lake Naval Air Weapons Station. The power is sold into the local utility grid. The package *geomapdata* contains a dataframe *cosomap* which contains location information on the "Coso Geothermal Region Faults and Geology". The following commands plot the fault lines on a Google map tile in Fig. 4.

The bulk of the remaining code deals mainly with efficiency as well as exploiting the many features offered by the Google Maps API. For repeated plotting on the same static map, the user most likely does not want to request the same map over and over again. By setting  $NEWMAP = F$  in `GetMap.bbox()` the function itself reads the map straight from the file specified by *destfile*. Furthermore, in order to not repeatedly read the map from a file, it can be stored and passed to most functions in the list *MyMap* that additionally contains information on the zoom level and the center.

Future versions will include the ability to handle jpg files in addition to png. In terms of features, the Static Maps API defines map images using the following URL parameters:

- `center` (required if markers not present) defines the center of the map, equidistant from all edges of the map. This parameter takes a comma-



separated latitude,longitude pair (e.g. "40.714728,-73.998672") identifying a unique location on the face of the earth. For more information, see latitudes and longitudes below.

- zoom (required if markers not present) defines the zoom level of the map, which determines the magnification level of the map. This parameter takes a numerical value corresponding to the zoom level of the region desired. For more information, see zoom levels below.
- size (required) defines the rectangular dimensions of the map image. This parameter takes a string of the form `valuexvalue` where horizontal pixels are denoted first while vertical pixels are denoted second. For example, `500x400` defines a map 500 pixels wide by 400 pixels high. If you create a static map that is 100 pixels wide or smaller, the "Powered by Google" logo is automatically reduced in size.
- format (optional) defines the format of the resulting image. By default, the Static Maps API creates GIF images. There are several possible formats including GIF, JPEG and PNG types. Which format you use depends on how you intend to present the image. JPEG typically provides greater compression, while GIF and PNG provide greater detail. For more information, see Image Formats.
- maptype (optional) defines the type of map to construct. There are several possible maptype values, including satellite, terrain, hybrid, and mobile. For more information, see Static Maps API Maptypes below.
- markers (optional) define one or more markers to attach to the image at specified locations. This parameter takes a string of marker definitions separated by the pipe character (`|`). Note that if you supply markers for a map, you do not need to specify the (normally required) center and zoom parameters. For more information, see Static Map Markers below.
- path (optional) defines a single path of two or more connected points to overlay on the image at specified locations. This parameter takes a string of point definitions separated by the pipe character (`|`). Note that if you supply a path for a map, you do not need to specify the (normally required) center and zoom parameters. For more information, see Static Map Paths below.
- span (optional) defines a minimum viewport for the map image expressed as a latitude and longitude pair. The static map service takes this value and produces a map of the proper zoom level to include the entire provided span value from the map's center point. Note that the resulting map may include larger bounds for either latitude or longitude depending on the rectangular dimensions of the map. If zoom is specified, span is ignored.
- frame (optional) specifies that the resulting image should be framed with a colored blue border. The frame consists of a 5 pixel, 55% opacity blue border.

- hl (optional) defines the language to use for display of labels on map tiles. Note that this parameter is only supported for some country tiles; if the specific language requested is not supported for the tile set, then the default language for that tile set will be used.
- key (required) identifies the Maps API key for the domain on which this URL request takes place. If you don't have a Maps API key, you can sign up for one free.
- sensor (required) specifies whether the application requesting the static map is using a sensor to determine the user's location. This parameter is now required for all static map requests. For more information, see Specifying Locations below.

## 2 Appendix: MapMath Details

We measure latitude and longitude in degrees but assume that the trigonometric functions used below expect units to be in radians.

With  $\tilde{lat} = \pi \cdot lat/180$ , the transformation from lat/lon to pixels is given by:

$$\tilde{Y} = \frac{1}{2\pi} \log \left( \frac{1 + \sin(\tilde{lat})}{1 - \sin(\tilde{lat})} \right) \quad (1)$$

$$Y = 2^{zoom-1} * (1 - \tilde{Y}), X = 2^{zoom-1} * (\tilde{X} + 1) \quad (2)$$

where  $\tilde{X} = lon/180$ . The integer part of  $X, Y$  specifies the tile, whereas the fractional part times 256 is the pixel coordinate within the Tile itself:

$$x = 256 * (X - \lfloor X \rfloor), y = 256 * (Y - \lfloor Y \rfloor)$$

Inverting these relationships is rather straightforward. Eq. (1) leads to

$$\tilde{lat} = 2\pi n \pm \sin^{-1} \left( \frac{\exp 2\pi \tilde{Y} - 1}{\exp 2\pi \tilde{Y} + 1} \right) + \pi, n \in \mathbb{Z} \quad (3)$$

whereas inverting Eqs. (2) gives

$$\tilde{Y} = 1 - Y/2^{zoom-1}, \tilde{X} = X/2^{zoom-1} - 1$$

For longitude, the inverse mapping is much simpler: Since  $\tilde{X} = lon/180$ , we get

$$lon = 180 \cdot (X/2^{zoom-1} - 1).$$

As a final remark, note that while latitude increases heading north, Google maps  $Y$  coordinates move opposite, i.e. increase southward.

## 2.1 Other Projections

How do the Mercator type projections from the *proj4* library compare to the projection applied in the function *LatLon2XY* ?

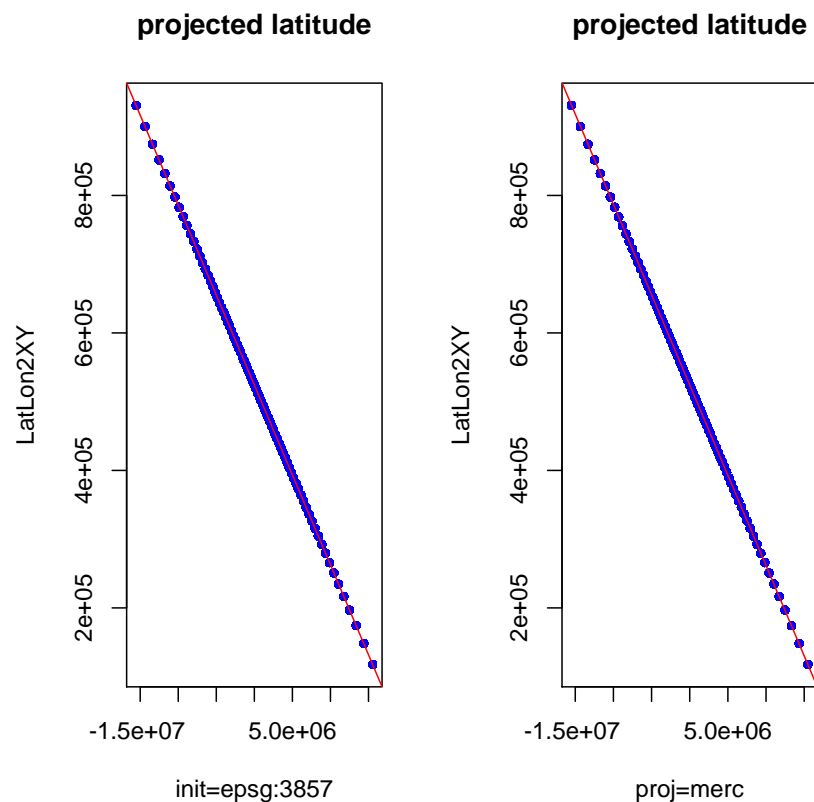


Figure 5: Comparing projections.



We see that the *init=epsg:3857* projection is indistinguishable from the Google API one (except for a linear transformation).

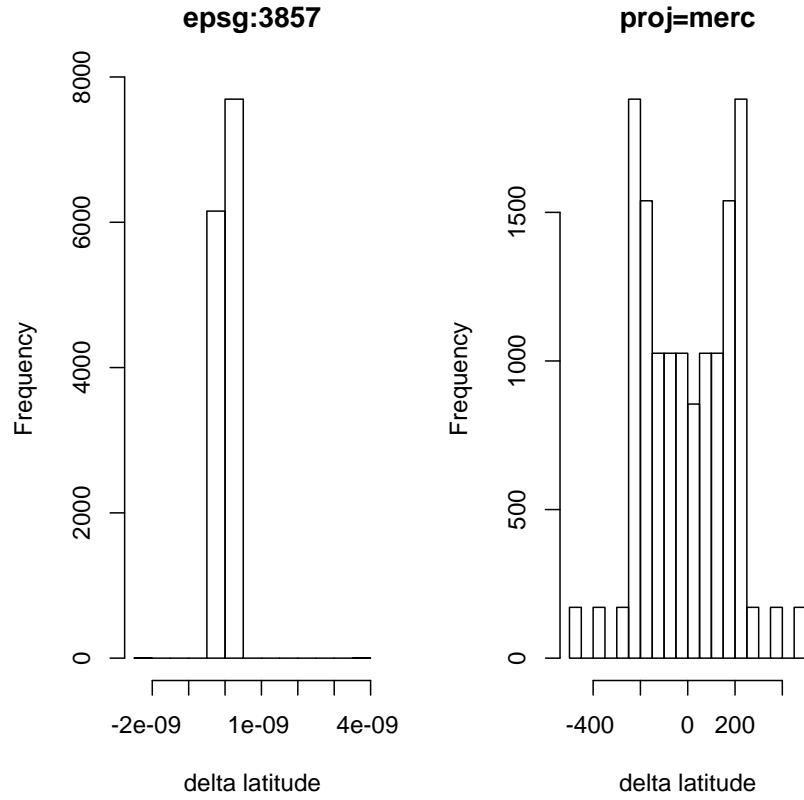


Figure 6: Deviations in projected latitude values for the projections.
